- **1.** Their wards should be carrying -ve corona report (72 Hours RTPCR) before entering the hostel.

- **3.** Their wards will visit their homes only during Diwali vacations.
- 4. Their wards will get only 2 hours outing only on Sunday (10:30am to 12:30pm) while residing in the hostel.
- 5. Guests, friends and relatives are not allowed in the hostel.

**6.** Their wards will follow all the SOP's recommended by MHRD, Dept. of Higher Education Govt. of India.

- It is mandatory for the students to install the <u>Aarogya Setu App</u> and keep Bluetooth and location on, all the time.
- It will be the responsibility of the students & their parents to follow all the rules & regulation related to Covid-19.
- **9.** Student residing in the hostel have to pay hostel fees (Rs. 3600/per semester) as per institution norms.
- 10. Mess charges are Rs. 2300/per month.
- **11.** The institute reserves the right to expel any students from the hostel if students does not follow the above rules and other restrictions issued by **Government of India/HPU/Institute**.
