Second Provisional Merit List

for Admission to M.Sc. Zoology First Year Session 2026–27

The Second Provisional Merit List for admission to M.Sc. Zoology First Year for the academic session 2026–27 is hereby displayed for the information of candidates who applied for admission online and attended the counselling/document-verification process held on 14 and 15 July 2026.

The candidature of any candidate may be cancelled at any stage if the information furnished in the online admission form or the documents submitted by the candidate are found to be false, incorrect or misleading.

Candidates who applied for admission and attended the counselling/document-verification process but whose names have not been included in the merit list on the basis of merit, or who have any objection regarding the merit list, should bring the matter to the notice of the Admission Committee immediately, but not later than **12:00 noon on 25 July 2026**.

Provisionally admitted candidates may deposit the admission fee online by logging in to their accounts on the college admission portal from 25 to 26 July 2026.

All admissions are provisional and subject to verification of all requisite original certificates by the Admission Committee, in accordance with the eligibility norms prescribed by Himachal Pradesh University for admission to the M.Sc. Zoology programme.

The 120-point reservation roster approved by Himachal Pradesh University, Shimla, for admission to postgraduate courses has been applied from Roster Point Nos. 91 to 120, in continuation of the roster followed in previous years.

The Admission Committee reserves the right to make necessary corrections to the merit list if any error or discrepancy is noticed at any stage.

The documents submitted or uploaded by some applicants are either unclear or incomplete or contain discrepancies. Although the names of such candidates have been included in the provisional merit list, their applications will be finally approved for fee payment only after all requisite documents have been properly submitted/uploaded and verified.

If seats remain vacant after completion of the admission process against the Second Provisional Merit List, the Third Provisional Merit List will be displayed on 27 July 2026.
