The candidature of students can be cancelled, if, it is found later on at any stage that the information provided by the student in the admission form is false.

As the number of applicants is lesser than number of seats, no roster has been applied and all eligible candidates are included in the admission list.

If any student has applied for admission but his/her name is not in this list or any other discrepancy is noticed in this list, bring it into the notice of admission committee immediately.

The students are advised to submit the hard copies of Admission Form and self-attested copies of necessary documents, to the concerned Major Subject Teacher on or before 02-08-2024.

The Fee Link will be available in the Student's Login Account of the college portal. The students can make the fee payment through Online Mode up to **Aug 01, 2024** through their college portal login account. In case of the failure to make the payment within stipulated time period, their claim for admission will be forfeited and candidates in waiting will be considered.

All admissions are provisional and subject to the verification of all requisite original certificates by the admission committee as per H.P. University norms with respect to eligibility for admission to B. Sc. Courses. Compartment case students are not eligible for the admission. Admission against this list will be regularised only after verifying the original documents by the admission committee.

Admission committee reserves the right to make corrections to this list, if, any discrepancy is noticed later on at any stage.

Documents uploaded by some applicants are either not clear, or have some other discrepancies, though their names have been included in the list but their application forms will get final approval for fee submission only after the submission/uploading of all requisite documents.

Many candidates with gap year (s) have not submitted undertaking about the gap or the recent character certificates (not older than 6 months). They all are directed to submit the same.
