ABOUT CAPTAIN VIKRAM BATRA



Captain Vikram Batra was born on 9 September 1974 in **Ghuggar** village near **Palampur, Himachal Pradesh**, to G.L. Batra and Jai Kamal Batra. He got his primary education from his mother, who herself is a teacher. He received his education up to Middle Standard at the **D.A.V. Public School** in **Palampur**. After passing 10+2 in 1992 from **Central School Palampur**, he got admitted in **D.A.V. College, Chandigarh** in B.Sc. where he was adjudged the best **N.C.C. Cadet** (Air Wing) in two zones. Later, he was selected to join the **Indian Military Academy** in **Dehradun** in 1996 in **Jessore Company** of **Manekshaw Battalion**, and was commissioned in the **Indian Army** as a **Lieutenant** of the **13 Jammu & Kashmir Rifles** at **Sopore**, in **Jammu & Kashmir**. He rose to the rank of **Captain**. On the eruption of a war-like situation in **Kargil, Dross** and **Batalik** sub-sectors in July 1999, **Captain Vikram Batra** was sent along with his company on the first strategic and daring operation to recapture the first peak of utmost importance- Point 5140, which was at an altitude of 17,000 feet. **Captain Vikram Batra**, 13 JAK Rifles, and his **Delta** Company was given the task of recapturing Point 5140. Nicknamed **Sher Shah** ('Lion King') in **Hindi** for his courage, he decided to lead from the rear, as an element of surprise would help stupefy the enemy. He and his men ascended the sheer rock-cliff, but as the group neared the top, the enemy pinned them on the face of the bare cliff with machine gun fire. Captain Batra, along with five of his men, climbed up regardless and after reaching the top, hurled two grenades at the machine gun post. He single-handedly killed three enemy soldiers in close combat. He was seriously injured during this, but insisted on regrouping his men to continue with the mission. Inspired by the courage displayed by **Captain Batra**, the soldiers of 13 JAK Rifles charged the enemy position and captured Point 5140 at 3:30 a.m. on 20 June 1999. He attained martyrdom when he tried to rescue an injured officer during an enemy counterattack against Point 4875 in the early morning hours of 7 July 1999. For his sustained display of the most conspicuous personal bravery and leadership of the highest order in the face of the enemy, **Captain Vikram Batra** was awarded the **Param VirChakra**, India's highest military honor on 15 August 1999, the 52nd anniversary of India's independence. To shower the respect to the great patriot, the H.P. Government has rechristened this College to **Saheed Captain Vikram Batra Government College, Palampur**. We are proud to announce that the college has always tried to live up to the expectations desired by the society and the students.

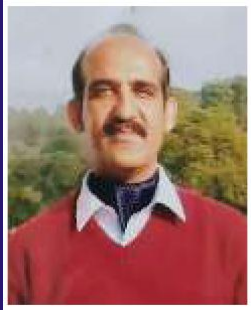

MESSAGE FROM THE CO-ORDINATOR BCA

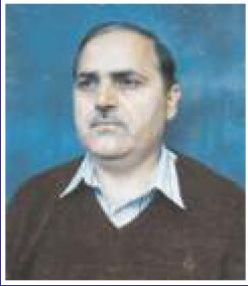

SCVB Government College Palampur - An Introduction

The town of Palampur is situated in a small valley priding itself with tea gardens, and hills covered with pine trees. The place enjoys a year-round pleasant climate and the pine scented air is said to have curative properties. The scenery presents a sublime and beautiful contrast-the valleys presents a picture of rural innocence and repose, while the hills are majestic. Overlooking this town are the majestic *Dhauladhars*, whose tops remain covered with snow for most of the year. This place is thronged by tourists and is now being developed as a large tourist centre. SCVB Government College, Agricultural University and a Central Scientific Research Institute's IHBT are pride of the town.

Known as the '*Tea Capital of North India*', Palampur is a beautiful hill station located in Kangra Valley in Himachal Pradesh. However, the town of Palampur was founded by Dr. Jameson who served as the superintendent of Botanical Gardens. He brought tea bushes from Almora and started its cultivation in Palampur. Following the successful plantation, European Tea Estate owners followed suit and started extensive tea plantations in the town. Since then, Palampur achieved international fame for its tea plantation. The town of Palampur gets its name from 'Pulum' which means 'abundant water'. The region has innumerable streams and brooks flowing across the region which in turn has been a boon for tea plantations.

In the field of education and to fulfill the aspirations of people in and around Palampur region, Govt. College, Palampur (Kangra) came into existence in year 1995 vide Govt. of Himachal Pradesh, Education Department Notification No. *Chha(15), 3/86-Shiksha ka-11 Dated 07-04-1995*. The College is recognized by UGC under section 2(f) & 12(B) of the UGC Act, 1956, vide letter No. *8-471/2008(CPP-I) dated 29 Sep, 2009*. The college is affiliated to Himachal Pradesh University, Summer Hill, Shimla-5. The college offers under-graduate courses in Humanities, Sciences, Commerce, Business Administration, Computer Applications and Post Graduate course in Economics. Besides this, the college will add few more gems in the field of education in form of Add-On courses and Post Graduations in near future.

This handbook of information/prospectus serves as a quick reference manual for BCA & BBA programmes and other rules & regulations of the College/Institution. The amendments made by H.P. **BCA & BBA:
COURSE,
ELIGIBILITY,
AGE LIMIT
AND BASIS OF
ADMISSION**

1. Course:

Both Bachelor of Computer Applications (BCA) and Bachelor of Business Administration (BBA) are three year Degree Courses having Semester system of examination spread over six semesters under Self-Financing scheme. The distribution of seats for both the courses are as under:

Total number of seats	60+1*
Subsidized seats	40
Non-Subsidized seats	20

* One seat is reserved for single girl child (SGC).

2. Eligibility:

Plus two examination in any discipline under 10 + 2 scheme or any other examination equivalent thereto, of Board/University established by law in India with at least 40% marks {35% marks for SC/ST category}.

3. Age Limit:

Maximum age limit for admission to BCA course is 21 years for the general category, 24 years for SC/ST category and 23 years for the girl candidates as on 1st July of the year concerned. The Vice Chancellor may permit age relaxation upto maximum of three months.

BASIS OF ADMISSION

Subsidized Seats :

The admission to both BCA and BBA will be purely on the basis of merit obtained in 10+2 class from CBSE / ICSE / HP Board of School Education or any other equivalent board recognized by Govt. of India.

Non-Subsidized Seats:

This scheme admits students as per the merit examination. The candidate seeking admission under non-subsidized category must submit his/her application on a plain paper with the Co-ordinator on 18/08/2021. After filling the seats in the subsidized category, top 10 candidates in the merit list who have applied separately for non-subsidised category will be admitted in this category.

In addition to the eligibility conditions mentioned above(under subsidized category), NRIs/NRI Sponsored/ Foreign nationals shall be required to submit along with the application form, the following documents as may be applicable for category of their candidature.

- A. Proof of nationality is case of Foreign Nationals.
- B. Proof of their status in the case of NRI's. For this purpose, either of the following documents shall be considered as a proof.
 - (i) Copy of Non-resident card/Employment card issued by the employer.
 - (ii) Photocopy of the immigration card/employment VISA entry on the passport alongwith details of the passport.
 - (iii) Certificate issued by the Indian Embassy/High Commission in the country where NRI is residing.
- C. Certificate of sponsorship from NRI in the case of a sponsored candidate, along with proof of NRI status of the sponsor required under para (B)

**RESERVATIONS
(Ordinance 3.1)**

- D. Photocopy of the latest assessment order of the Income-tax authorities in India and the Permanent Account number (PAN) of the sponsor issued by the Income Tax Department.
- E. Two self addressed envelopes of size 28X13 cm bearing stamps for Rs.6 or in the case of Foreign addressee stamps of required amount should be affixed by the applicant. Admission to the courses except for seats reserved for NRI's/NRI sponsored and foreign students shall be subject to the following conditions:
 - (A) 15% and 7.5% seats shall be reserved for Scheduled Caste and Scheduled Tribe candidates respectively, who have passed their qualifying examination from H.P. Board of School Education, or any other school located within the territorial jurisdiction of Himachal Pradesh affiliated to any other Education Board e.g. CBSE or ICSE board etc. However, reservation of seats will be governed by notification of the Government from time to time.
 - (B) The remaining 77.5% seats shall be filled as under:-
 - (i) 25% of the seats for admission to the course shall be open for all the candidates irrespective of the institution from which they have passed their qualifying examination.
 - (ii) 75% of seats shall be filled out of the candidates who have passed their qualifying examination from H.P. Board of School Education or any other school located within territorial jurisdiction of Himachal Pradesh affiliated to any other Education Board e.g. CBSE or ICSE Board etc. subject to the following reservation:
 - (a) 5% of all seats shall be reserved for outstanding sportsmen.
 - (b) 5% of the seats shall be reserved for the outstanding cultural activists.

{c) 5% of the seats shall be reserved for specially abled candidates.

{d) Provided that the minimum eligibility for admission to the course in case of SC/ST will be 5% lower than the eligibility conditions for other candidates.

The admission to these reserved seats as stated at {a), {b) & {c) to para {ii) of clause {B) above shall be made as per procedure/rules approved by the Executive Council from time to time.

(NOTE: Any change in the reservation of seats as per the notification of the H.P. Govt. or HPU Shimla will be implemented from the date of notification.)

OR

200 points roster of H.P. University showing reservation of various categories for admissions shall be followed.

NOTE: Roster for admission will be as per the latest notification of H.P. Govt/HPU Shimla

Application form duly filled and accompanying the following documents should be filled online on the college official website ***www.gcpalampur.ac.in***.

- {i} Attested copies of the certificates of Matriculation or its equivalent examination and Plus Two {10+2} or its equivalent examination with the conversion formula of grade into percentage wherever applicable with relevant testimonials.
- {ii} Proof of date of birth {if not given in the Matriculation Certificate, Attested photocopies of supporting documents}.
- {iii} Attested copy of latest Character Certificate and a copy of Aadhar Card.
- {iv} Bonafide certificate for the girls of Himachal Pradesh if they want an exemption from the tuition fee.
- {v} Attested copy of the certificate of reserve category.

The candidate will have to produce the original certificates and should be accompanied by the parents (Father or Mother) at the time of admission.

This would have the following components:

- (A) Classroom Attendance (i) Each student will have to attend a minimum of 75% Lectures/Tutorials/Practicals. A student having less than 75% attendance will not be allowed to appear in the End-Semester Examination (ESE)/ Practical.
- (ii) Those having between 74% and 65% attendance will apply for exemption in a prescribed form accompanied by clear reason(s) for absence to the head of the institution.
- (iii) Those having between 64% and 50% attendance will apply for exemption in a prescribed form accompanied by a Medical Certificate from a Government Hospital to the head of the institution.
- (iv) The exemption from 75% attendance will be given to those participating in prescribed co-curricular activities (e.g. NCC, NSS, Youth Festivals, Sports etc.) to the extent of 25%. However the condition of 50% attendance will be compulsory in these cases. The claim for this exemption should be supported by authenticated certificate from the concerned authorities.
- (v) The candidates those getting the exemptions, except for those getting exemptions for co-curricular activities, will not be entitled for getting the CCA marks for classroom attendance as given below.
- (B) Classroom Attendance Incentive: The incentive for the classroom attendance (for those participating in Co- curricular activities, 25% will be added to per cent attendance) will be awarded CCA marks as follows:-
= 75% but < 80% 1 mark; = 80% but < 85% 2 marks; = 85 but < 90% 3 marks; = 90% but < 95% 4 marks and 2'. _95% 5 marks
- (C) Mid-Term (Minor) Tests (i) There will be two mid-term tests, first after 48 teaching days (8 weeks) covering the syllabus covered so far, and second after 90 teaching days (15 weeks) covering the syllabus after the first minor test. Each of these mid-term tests will be for 15 marks. The stationary for the minor tests, e.g. the 20-page test booklet, will be provided by the college/ Department as the case may be, for which fee may be charged.
- (ii) Question paper for the minor tests will be made by the teacher of the course and will be evaluated by him/ her. If more than one teachers are teaching the course, they will set paper on rotation basis

END SEMESTER EXAMINATION (ESE)

- (iii) Evaluated test booklets will be provided to the students (shown in the class) and they can be given photocopies of the same for the cost of photocopying and the administrative effort involved. The amount chargeable will be determined by the college administration.
- (iv) In laboratory courses (having only practical (P) component), the students will be tested on the basis of laboratory exercises given by the course teacher concerned. Rest of the procedure will remain the same as above.
- (v) For the Correspondence Courses and Distance Education Courses (through the ICDEOL of the HPU) the same can be done in an on-line mode through e-mail or other electronic mediums as per Distance Education Council, New Delhi guidelines.
- (D) Seminar/ Assignment/ Term Paper The remaining 15 marks of the CCA will be awarded on the basis of seminar/ assignment/ term paper etc. that the course teacher might give to the students. For the Correspondence Courses and Distance Education Courses (through the ICDEOL of the HPU) the same can be done in an on-line mode through e-mail or other electronic mediums as per Distance Education Council, New Delhi guidelines and the best practices for distance education mode or on the basis of well designed written assignments by post.

The remaining 50% of the final grade of the student in a course will be on the basis of an end-semester examination (ESE) that will be for three hours duration and will be covering the whole syllabus of the course.

- (i) For the Odd Semesters the ESE will be in the month of October/ November and for Even Semesters it will be in the month of April/ May (as decided by H.P. University).
- (ii) A candidate who does not pass the examination (ESE) in any course(s) (or due to some reason is not able to appear in the ESE, other conditions being fulfilled, and so is considered as 'Fail'), shall be permitted to appear in such failed course(s)' ESE in the subsequent ESE to be held in the following October/ November or April/ May as the case may be.
- (iii) The registration for the ESE will be done at the time of the enrollment for the course at the beginning of the semester. The fee for the ESE will also be collected at that time as decided by the university from time to time.
- (iv) If a student is not permitted to appear in the ESE due to shortage of attendance beyond the exemption limit (< 50% attendance) shall be deemed to have 'dropped'

the course. However such candidate, on his/ her written request to be made immediately, can be permitted to redo the missed semester after completing the rest of the programme or whenever the course is offered subsequently. This redoing would mean complete course including CCA and ESE.

A formal dress code implies cultivation of special attitude and gives a different look to the students and also adds to his/her personality. The dress code will be observed for five days a week i.e. Monday, Tuesday, Thursday, Friday, Saturday.

1. College will charge fee for academic year for full twelve months in two installments. The fee is to be deposited by the candidate at the time of admission on the dates mentioned on page no. 2 failing which seat will be allotted to the next candidate in the merit list.
2. Refund of security is permitted within a year after the completion of the course failing which security will stand forfeited.

Leave Rules

1. All students are expected to attend their classes regularly and punctually. In case the candidate is unable to attend the class he/she may apply leave on the proper application form.
2. Before proceeding on leave, it must be got sanctioned from appropriate authority and submitted to the office.
3. In case of illness the leave application must be supported by medical certificate from Govt. hospital indicating the period advised for rest.
4. Leave up to two days will be sanctioned by tutor, up to four days by senior tutor/ coordinator and more than four days only by the Principal, on the recommendation of the coordinator.

Identity Card

Every student will be issued an identity card and will wear the card all the time while on the campus. The college authorities may ask the candidate to produce the same at anytime.

House Test/ Examination

1. The house tests will be conducted in the month of December/January. All the students are here by advised to appear in house examinations.
2. As per H.P. university norms, each candidate must get a minimum of 20% marks in each subject (or 25% in aggregate) in order to be eligible to appear in the annual examination. If the candidate does not satisfy this condition, her/his candidature will be withheld/ cancelled.

CODE OF CONDUCT AND GENERAL RULES

Fine

1. Absence fine per period is Rs.1/-
2. Library fine is Rs.1/-per day per book.
3. Absence fine for class test is Rs. 10/-
4. Absence fine for practical class is Rs. 10/-
5. Absence fine for Seminar is Rs. 10/-
6. Absence fine for Tutorial class is Rs. 10/-
7. Fine for not wearing dress is Rs. 50/- per day.

Attendance

1. The students must ensure that their attendance in each subject must be above 75%.
2. In case of shortage their candidature will be withheld and they won't be able to appear in annual examinations.

Lecture shortage will be notified from time to time for the information of the students.

1. Observance of the college rules and regulation is compulsory. Ignorance of the rules and regulation/orders issued from time to time is no excuse. Students are expected to go through the hand book of information and College notice board regularly.
2. Students are expected to conduct themselves in graceful and dignified manner.
3. Each student is expected to observe the college dress code strictly.
4. Each student is expected to be present regularly in the College (Expect during leave).
5. Name will be struck-off if the candidate remains absent continuously for 10 days. Candidate can seek re-admission after satisfying the Principal for the absence within 10 days. However, it is the discretion of the Principal to refuse the admission (*First Re-admission Fee is Rs. 100/- and Second Re-admission fee is Rs. 200/- within 7 days only that too in the presence of parents*). *After that no re-admission is allowed.*
6. No student is allowed to put poster in College campus/notice board, and to hold assembly in college premises or to address an unauthorized gathering on the college campus.

7. Silence is to be strictly observed. Students causing disturbance/Obstruction in the smooth functioning are liable for disciplinary action.
8. The students causing loss to the College property will be penalized and asked to make good for the loss.
9. For other rules/regulations the students are directed to consult the College Prospectus and H.P. University Ordinance.
10. The use of Mobile Phones or any other type of electronic gadgets is strictly prohibited. The defaulters will be severely dealt with and fine up to Rs. 500/- may be imposed on them.
11. No student is authorized to accompany/come with an outsider in the College premises. The defaulters will be sternly punished along with fine and outsider will be handed over to Police.
12. The College does not take the responsibility for postal delay or loss of any document and letter in transit.
13. Suppression of any information or furnishing any false information by a candidate will lead to immediate cancellation of his/her admission at any time. In such cases fee paid shall not be refunded.
14. The information given is an indication of the College/University's plans as on date of publication of this document. Details can be modified from time to time for academic and operational reasons. The students will be governed by latest regulations applicable to them.
15. In the event of any inconsistency in the rules for admissions/examinations or in the event of any clarification with respect to above said rules/instructions or any other matter, the decision of the Vice-Chancellor/Principal shall be final and no claim, what so ever, shall be entertained.

**CURBING
RAGGING IN
THE INSTITUTE:**

Ragging in institute is strictly banned according to the judgement and directions of Hon'ble Supreme Court of India, Himachal Pradesh University and guidelines issued by UGC in this regards. The following guidelines will be observed to prevent of ragging in the institute.

1. Every candidate seeking admission will give undertaking duly printed on the application form that he/ she will not indulge in ragging and if found guilty he/she will be liable punishment. Similar undertaking will be obtained from the parents/guardian of the applicant.
2. Anti Ragging committees has been constituted in the College.
3. Whenever a ragging incident is brought to the notice of the College authorities, the disciplinary committee will hold an enquiry in to the incident.
4. If any student is found guilty of ragging, after the enquiry then he/she will be punished accordingly. The punishment may include:-

 - iv) Withholding scholarship or other benefits
 - v) Debarring from the representation in events.
 - vi) Suspension or expulsion from hostel or mess.
 - vii) Legal proceeding under criminal law shall be initiated.
5. If any student is found guilty of ragging incident occurred in the past then he/she may be expelled from the institution.
6. As per the judgement of the Hon'ble Supreme Court delivered on 8th May, 2009 and UGC/AICTE Regulations that all the students will have to fill an Anti-Ragging undertaking every year. The undertaking can be filled online at www.antiragging.in or www.amanmovement.org.

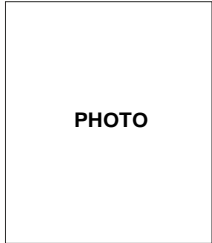

"RAGGING IS A COGNIZABLE OFFENCE"

Ragging is originally a Western Concept and was considered a form of social interaction between seniors and juniors in educational institutions. However, with the passage of time these interactions have taken a very brutal, inhuman and anti social form. The Hon'ble Court has defined ragging as a non-acceptable conduct whether by words spoken or written or by an act having a teasing effect, treating or handling any other student with rudeness. It also include indiscipline activities which may cause any kind of harm or raise fear among the fresher or junior student or asking the student to do any act to perform something which a student will not do under normal circumstances or which has the effect of causing or generating shame or embarrassment so as to adversely affect the psyche of the new entrant of the college. If any student is found indulging in this heinous act, directly or indirectly, the college authority will take strict action against the guilty under rule 22, 17(a, b, c, d) of the H.P. University Ordinance.
